This "Catalogue of the Peruvian Offer of International Technical Cooperation 2022" has identified 34 successful experiences developed by Peruvian institutions that can be shared with partner countries. The impact of the COVID-19 pandemic is the most serious and complex challenge that our countries are currently facing. Its serious economic and social effects have increased and highlighted the inequalities and development gaps already present in the reality of countries, such as Peru, at the regional and global level. They pose a real threat not only to the progress made in implementing the 2030 Agenda for Sustainable Development, but also to the deteriorating conditions for post-pandemic recovery and development. An effective response requires strengthening multilateralism alongside cooperation schemes. Therefore, international cooperation faces these challenges on the basis of previous agreements such as the implementation of the recommendations of the outcome document of the Second UN High-Level Conference on South-South Cooperation (BAPA+40).

It recognises the voluntary, participatory and demanddriven nature of South-South and Triangular Cooperation, as well as its positioning as a vehicle for strengthening capacities, reducing asymmetries, promoting sustainable and inclusive development and developing public policies for mutual benefit. Therefore, within the framework of the new National Policy on International Technical Cooperation - in the process of approval - it is established among its priority objectives and guidelines to strengthen these schemes, with emphasis on the Peruvian Offer of International Technical Cooperation (OPCTI, by its acronym in Spanish). Peru recognises the important potential of these modalities as a complement to traditional cooperation, allowing the sharing of knowledge, capacities and experiences with other developing countries, based on principles of mutual benefit, solidarity and complementarity. This emphasis is reflected in the present document "Catalogue of the Peruvian Offer of International Technical Cooperation 2022", which identifies 34 successful experiences developed by Peruvian institutions that can be shared with partner countries in seven sectors:

i) Climate Change, Forestry and Biodiversity; ii) Water, Sanitation and Water Resources; (iii) Disaster Risk Management; (iv) Sustainable Cities and Transport; v) Citizen Security and Organised Crime; vi) Health and Food Security; vii) Technological Innovation, TICs and Supply Chains and viii) Education and Gender Equality. In this sense, the main forms of cooperation are the exchange of experiences, short stays of experts, courses or seminars, internships, among others.

The entire offer maintains the possibility of being offered in virtual or physical format, with Spanish being the prevailing language and English to a lesser extent. National Service of Natural Areas Protected by the State (SERNANP)

The National Service of Natural Areas Protected by the State (SERNANP) is the governing body of the National System of Natural Areas Protected by the State (SINANPE). As a technical and regulatory authority, its mission is to sustainably manage biological diversity and maintain the ecosystem services that provide benefits to society, through participatory and coordinated management with regional and local governments and owners of land recognised as private conservation areas through regulations, technical-administrative criteria, procedures, supervision and control of Natural Protected Areas (NPAs) for the conservation of natural heritage and the sustainable development of the national economy.

Mechanisms for civil society participation in the management of Natural Protected Areas (NPAs)





Offer Details

Our offer is based on methodologies for the design of strategies, policies and instruments for participatory involvement and integration of various non-state actors (peasant organisations, native communities, natural resource extractors, the business sector, NGOs, among others) that contribute directly or indirectly to the management of the Natural Protected Areas (NPAs) system.



Experience

Peru is one of the pioneering countries in terms of the involvement of strategic actors and members of civil society in the management of Natural Protected Areas (NPAs). The experience acquired contemplates the social and economic development of communities through the exploration of the opportunities offered by Natural Protected Areas (NPAs) in local development, seeking to contribute to the improvement of the quality of life of their inhabitants with participatory platforms and manoeuvres. In 2018, together with Brazil, the "Amazonía 2.0" project was developed. Through the design of a training plan, a community monitoring programme was implemented in the Purús sector (Acre, Brazil), benefiting local researchers and environmental monitors.







Ministry of the Environment (MINAM)

The Ministry of Environment (MINAM) promotes the conservation and sustainable use of natural resources, the enhancement of biodiversity and environmental quality for the benefit of people and the environment in a decentralised manner and in coordination with public and private organisations and civil society, within the framework of green growth and environmental governance. MINAM plans, directs, executes, supervises and evaluates the National Environmental Policy (PNA, by its acronym in Spanish) applicable to all levels of government, directs the National Environmental Impact Assessment System (SIGA, by its acronym in Spanish) and the National Environmental Impact Assessment System (SEIA, by its acronym in Spanish), exercising the steering role of the Environmental Sector.



Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES)



Offer 2

Preparation of Nondetrimental Extraction Findings (NDF) on International Trade in Endangered Species of Fauna and Wild Flora (CITES)





Offer Details

The Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) is responsible for ensuring that international trade in endangered wildlife species does not cause ecological damage and is conducted in a sustainable manner. Non-Detrimental Extraction Findings (NDFs) are one of the main tools for assessing the risk of international trade in wild fauna and flora, in order to ensure their sustainability over time. The Ministry of Environment (MINAM) has trained and experienced human capital in the formulation of Non-Detrimental Extraction Findings for flora and fauna, both terrestrial and aquatic. Our offer is based on the design of methodologies based on biological analysis, the development of practical cases, strategic guidelines and policies that allow us to contribute new knowledge, through experiences to share with the CITES scientific authorities and their collaborators.

Experience

Peru has a track record of case studies on flora and fauna that include CITES Appendix I and II species. This experience has allowed the development of training events for the issuance of Non-Detrimental Extraction Findings with CITES members in several Latin American countries of the Amazon Cooperation Treaty Organization (ACTO): Brazil, Bolivia, Colombia, Ecuador, Guyana, Suriname and Venezuela. In addition, in the Amazon region, together with the German Scientific Authority and Traffic, the first Non-Detrimental Extraction Findings workshop was developed under the document "The nine steps for Non-Detrimental Extraction Findings".

Efficient use of materials and solid waste management



Offer 3

Instruments for efficient use of materials and solid waste management





Offer Details

Through various strategies, the Ministry of Environment (MINAM) addresses the existing problem of integrated solid waste management at the national, provincial and district levels. In response to this, it provides technical assistance to local governments to strengthen their capacities in the proper management and management of solid waste in their respective jurisdictions. Our offer is based on the design of methodologies for the formulation of instruments that optimise the efficient use of materials and solid waste management.



Experience

Peru, through the Law on Integrated Solid Waste Management (LGIRS, by its acronym in Spanish), managed to regulate the management of solid waste, its control infrastructures, reuse and recovery activities, as well as its material and energy recovery. Its scope of action covers the regulation of the public cleaning service, establishing the minimum conditions for its execution through the promotion of public and private, municipal and non-municipal initiatives for the reduction of waste generation and hazardousness, as well as the recovery and adequate management of waste through coordination and agreement with sectoral authorities, regional governments and local governments. In 2020, a Binational Cabinet (Peru-Bolivia) was created for the integrated management of solid waste, prioritising its minimisation and recovery through the circular economy approach. The objective was sustainable production and consumption with a global and local perspective through the efficient use of natural resources and the reduction of polluting emissions through prevention, recycling and reuse, both in consumption and production.



Mechanisms for Remuneration for Ecosystem Services (MERESE)



Offer 4

Economic instruments for the sustainable management of ecosystem services





Offer Details

Peru, through the economic and financial instruments of the General Directorate of Environmental Economics and Financing, designs and promotes public and private investment for the conservation and sustainable use of biodiversity, ecosystem services and environmental protection. Its guidelines are materialised in the Mechanisms of Remuneration for Ecosystem Services (MERESE, by its acronym in Spanish) developed by the Ministry of the Environment (MINAM), which contribute to boost its implementation at the national level together with other ecosystem services and actors, in order to contribute to closing the gaps of degraded ecosystems. Our offer is based on the design of economic and financial instruments for the sustainability and improvement of ecosystem services.



Experience

In 2014, Peru passed the Law on Mechanisms of Remuneration for Ecosystem Services (MERESE, by its acronym in Spanish), and since 2021, through a programme of exchange of experiences between Peru, Chile and Costa Rica, the common theme is being addressed. This implementation had positive effects and is currently being applied through policies and instruments for dissemination and institutional strengthening aimed at the conservation, recovery and sustainable use of natural infrastructure at the international level in countries such as Colombia, Ecuador and Costa Rica.



Oefa

Agency for Environmental Assessment and Enforcement (OEFA)

The Agency for Environmental Assessment and Enforcement (OEFA) is the governing body of the National Environmental Assessment and Enforcement System (SINEFA, by its acronym in Spanish). As the main environmental inspector, it has the function of verifying that natural and legal persons comply with the provisions of environmental legislation in order to safeguard the balance between economic investment and environmental protection, contributing to the sustainable development of the country. It also supervises that the Environmental Enforcement Entities (EFA, by its acronym in Spanish) at the national, regional or local level carry out their functions in accordance with the provisions of the National Environmental Policy through their regulatory and sanctioning powers.

International technical exchange panels on environmental enforcement





Offer Details

Our offer is based on the design of technical exchange panels on environmental auditing through spaces for dialogue between specialists and international researchers on environmental auditing, as well as on the assistance of technical and legal experts on issues that fall within the competence of the Agency for Environmental Assessment and Enforcement (OEFA, by its acronym in Spanish) with the aim of generating new contributions on research proposals.



Experience

Since 2018, the Agency for Environmental Assessment and Enforcement (OEFA, by its acronym in Spanish) has developed peer review processes through the analysis of cases and technical scientific information in exchange panels between invited experts from international technical cooperation and OEFA teams. Between 2018 and 2021, 12 technical exchanges of national and international peers were held with institutions such as the United States Agency for International Development (USAID) and the United States Forest Service, where topics related to the control of sectors such as mining, hydrocarbons, industry, solid waste, agriculture, fisheries and environmental health were addressed.





WATER, SANITATION AND WATER RESOURCE





National Water Authority (ANA)

The National Water Authority (ANA) promotes water culture and is the highest technical and regulatory authority of the National Water Resources Management System (SNGRH, by its acronym in Spanish). It was created in 2008 with the aim of managing, conserving, protecting and exploiting the water resources of the different basins in a sustainable manner for the benefit of water users and the population. Its functions include the administration and monitoring of natural water sources, the authorisation of discharge and reuse of treated wastewater by water service providers and the evaluation of environmental instruments.

Blue Certificate: Methodologies for water resource management and optimization





Offer Details

The "water footprint" is an environmental indicator to determine the volume of freshwater and the costs involved in the production of goods and services. The "Blue Certificate" is a Peruvian initiative, unique and unprecedented in Latin America, which recognises enterprises that are committed to offsetting the impact of water use in their operations. It is a public-private instrument based on ISO 14046 methodologies developed by the Peruvian National Water Authority (ANA), the Swiss Agency for Development and Cooperation (SDC) and the 2030 Water Resources Group for integrated water resources management. Our offer is based on methodologies for the design of strategies and policies that incorporate technologies and innovations in water efficiency, aligned to productive processes for the benefit of the community to contribute to sustainable environmental management.

Exp

Experience

Since 2015, through the "Blue Certificate", Peru has been promoting water efficiency and water quality improvement policies. Its implementation has meant achievements such as: 1) More than 3 million cubic metres of water savings, 2) Reuse of 477 thousand cubic metres of water and 3) Improved treatment of 140 thousand cubic metres of water. Through this initiative, 42,000 people have benefited directly and indirectly and an investment of more than 2.5 million dollars from the private sector has been promoted. These experiences have been shared as a public-private management model with the member countries of the Global Water Partnership (GWP) in South America.

Methodologies for Integrated Water Resources Management (IWRM)





Offer Details

The Integrated Water Resources Management (IWRM) is a process that promotes, at the river basin level, the coordinated management and development of the multi-sectoral use and development of water and related natural resources. The objective is the development of the country without compromising the sustainability of ecosystems. Our offer is based on the design of strategies and policies that replace the traditional and fragmented approach to water management and use with a multilevel, multi-sectoral and multi-stakeholder approach, highlighting its economic, social and environmental value for the common good through a philosophy of equality and sustainability.



Experience

In 2019, together with the Honduras Ministry of Natural Resources and Environment, the General Water Law was implemented for the benefit of Honduras. The principles and regulations applicable to the integrated sustainable management of water resources at the national level were established, including its protection, conservation, valorisation and multi-sectoral use.









National Superintendence of Sanitation Services (SUNASS)

La Superintendencia Nacional de Servicios de Saneamiento (SUNASS) es un organismo público descentralizado con personería de derecho público y autonomía administrativa, funcional, técnica, económica y financiera. Su función es normar, regular, supervisar y fiscalizar la prestación de los servicios de saneamiento, cautelando en forma imparcial y objetiva los intereses del Estado, de los inversionistas y del usuario. Sus funciones buscan garantizar la prestación de los servicios de saneamiento en el ámbito urbano y rural con estándares de calidad, a fin de contribuir a la salud de la población y a la preservación del medio ambiente. Impone sanciones por el incumplimiento de las obligaciones derivadas de las normas legales o técnicas, así como de las obligaciones contraídas por los concesionarios contratados.



Mechanisms for the Remuneration of Ecosystem Water Services (MERESE-H)



Offer 8

MERESE-H as a public policy for the conservation of water sources from the potable water service





Offer details

The Mechanisms for the Remuneration of Ecosystem Water Services are mechanisms aimed at the conservation, recovery and sustainable use of the sources of ecosystem services, where an agreement is established between user(s) and taxpayer(s) to the service to generate, channel, transfer and invest economic, financial and non-financial resources for the benefit of the community and the environment. The National Superintendence of Sanitation Services (SUNASS) promotes the conservation of water-supplying ecosystems, preventing the degradation of hydrogeological basins in order to provide a higher quality and lower cost potable water service. Our offer is based on the design of strategies to link potable water companies with their hydrogeological basins and to contribute to the maintenance of water ecosystem services, through the implementation of Mechanisms for the Remuneration of Ecosystem Water Services (MERESE-H) for the benefit of the community and the environment.

Experience

In 2017, together with the Costa Rica Institute of Aqueducts and Sewerage (AyA, by its acronym in Spanish), a programme was successfully developed to design and implement a sanitation tariff capable of incorporating economic retribution for ecosystem services. In addition, in 2019, another programme was developed to strengthen the Bolivia Water and Basic Sanitation Authority (AAPS, by its acronym in Spanish) based on the Peruvian experience in this area. In both cases, new contributions in technical capacities were generated for the benefit of professionals and technicians from both institutions.



DISASTER RISK MANAGEMENT





Peruvian-Japanese Centre for Seismic Research and Disaster Mitigation (CISMID)

The Peruvian-Japanese Centre for Seismic Research and Disaster Mitigation (CISMID) was established in 1986 by the Faculty of Civil Engineering (FIC) of the Universidad Nacional de Ingeniería (National University of Engineering) (UNI) and financed thanks to the cooperation of the Government of Japan through its International Cooperation Agency (JICA). It is an institution of solid international prestige that, thanks to the contribution and quality of its researchers, has managed to position itself at the forefront of seismic engineering not only in Peru, but also in Latin America. During its 36 years of operation, it has contributed with a series of investigations to the implementation of infrastructure works of national and international importance.

Strategies and instruments for disaster risk prevention and reduction





Offer details

Our offer is based on the dissemination of knowledge and methodologies for disaster prevention and mitigation, through research and application of technologies that contribute to sustainable development in the fields of earthquake engineering, geotechnics, geomatics and planning focused on preventing natural disasters. The programmes cover topics such as seismic microzoning, seismic hazard, tsunami hazard, seismic and tsunami vulnerability, among others.



Experience

Between 2018 and 2022, the projects "Strengthening of the Functional Organisational Structure of the National Office for Seismic and Vulnerability Assessment of Infrastructure and Buildings (ONESVIE, by its acronym in Spanish)" and "Strengthening of Technical Capacities in Disaster Risk Reduction from Seismic Events" were developed for the benefit of the Dominican Republic. Based on this programme, a plan to improve ONESVIE's organisational structure was proposed and training was provided to its technical teams. The project is still in progress, and the Peruvian-Japanese Centre for Seismic Research and Disaster Mitigation is providing ongoing support. On the other hand, between 2019 and 2022, the project "Adobe as a local construction culture in El Salta" was developed for the benefit of Argentina. Through this project, the local population was trained on safe construction techniques with earth (adobe), providing general criteria for the construction, conservation and restoration of this architecture, revaluing an ancestral construction technique that is part of the cultural heritage of Latin America.

National Training Service for the Construction Industry (SENCICO)

The National Training Service for the Construction Industry (SENCICO, by its acronym in Spanish) is a special treatment entity of the Housing, Construction and Sanitation Sector whose purpose is the training of workers in the construction sector, the development of research related to housing and its construction, as well as the proposal of technical standards of national application. It provides excellent training, research, evaluation of innovative construction systems and proposes standards for the development of the construction industry, contributing to increasing the productivity of construction companies and improving the quality of life of the population.



Habitability of dwellings: Assessment and certification of biomass cookstoves



Offer 10

Evaluation and certification of biomass cookers





Offer details

The programme aims to determine how much the consumption of firewood and the greenhouse gases produced by biomass cookstoves can be reduced inside a house, based on evaluation and certification techniques, with the objective of reducing the rate of different diseases (respiratory diseases, vision, etc.) associated with the high carbon monoxide emissions emitted by these traditional cookstoves. Our offer is based on the design of evaluation processes for biomass cookers in the field (KPT and CCT) and laboratory by applying protocols, technical standards and regulations through comparative studies, considering energy efficiency, safety, durability, intra-domestic concentration of carbon monoxide and particulate matter (PM 2.5).



Experience

Energising Development (EnDev) is a global partnership funded by six donor countries (Germany, the Netherlands, Norway, the United Kingdom, Sweden and Switzerland) with the aim of promoting access to basic energy services for twenty million people around the world. Currently, the partnership is implemented by the German Development Cooperation (GIZ) in 26 countries in Africa, Asia and Latin America. In Peru, the project started in 2007 with a focus on Arequipa, and since 2009, it has been advising public and private institutions nationwide. In 2011 and 2013, EnDev, GIZ and the National Training Service for the Construction Industry (SENCICO) developed a project in villages in Ecuador where field evaluations were carried out using the Control Cooking Test (CCT) protocol.

The Ministry of Labour and Employment Promotion (MTPE, by its acronym in Spanish) promotes decent and productive employment, the fulfilment of labour and fundamental rights of the population, strengthening social dialogue, employability and protection of vulnerable groups from a citizen-centred vision. Designs, conducts and supervises functional systems in the field of labour and employment promotion, ensuring compliance with public policies in accordance with the relevant regulations. Promotes labour formalisation through information and advice to contribute to the creation and development of decent employment in line with the productive and sustainable development policies of the economy.

Exchange of experiences on the programmes *Emprende Seguro 1* (Safe Entrepreneurship 1) and *Emprende Seguro* 2 (Safe Entrepreneurship 2).





Offer details

As a result of the labour and economic crisis caused by Covid-19, the "Emprende Seguro 1 and 2" (Safe Entrepreneurship 1 and 2) programmes were created with the aim of restoring the livelihood of vulnerable Peruvians and Venezuelans. The programmes were developed between the International Labour Organisation, the Metropolitan Municipality of Lima, the National Superintendence of Migration, the United States Agency for International Development (USAID) and the Regional Governments of Peru, and were financed by USAID and the Spanish Agency for Development Cooperation. Our offer is based on sharing the lessons learned about formal independent entrepreneurship, covering topics such as: business training, promotion, seed capital, formalisation, social protection bonuses, financial education, micro-credits, psychosocial support and soft skills, among others.



Experience

The "Emprende Seguro 1" (Safe Entrepreneurship 1) benefited 750 entrepreneurs in Lima by strengthening their entrepreneurial skills with technical assistance for their businesses and facilitating access to financial resources. Nearly 468 business improvement plans were developed, seed capital was distributed to nearly 750 people, 207 entrepreneurs were trained in financial resource management and 34 savings and credit groups were created, among other activities. In the Emprende Seguro 2 (Safe Entrepreneurship 2) 471 entrepreneurs in 5 regions of Peru benefited from training in business management using methodologies such as ISUN, GET Ahead, SCORE and financial education.





Ministry of Housing, Construction and Sanitation (MVCS)

The Ministry of Housing, Construction and Sanitation (MVCS) is the national governing body for urban planning, housing, construction and sanitation, responsible for designing, regulating, promoting, supervising, evaluating and executing sectoral policy, contributing to the competitiveness and sustainable territorial development of the country, preferably for the benefit of the poorest population. Its purview extends to natural and legal persons that carry out activities linked to the related sub-sectors. The Ministry of Housing, Construction and Sanitation has the mission to improve the living conditions of the population, facilitating their access to adequate housing with basic services, encouraging the participation of civil society and private investment.

Offer details

The Bono Familiar Habitacional (BFH) (Family Housing Bonus) is a subsidy granted by the Peruvian government to low-income families so that they can buy or build a house through the *Techo Propio* (Own Roof) programme. Our offer is based on the design of strategies and policies to serve a greater number of families through credits and housing bonds, as well as to incorporate actions aimed at improving human settlements, urban land management and disaster risk management in the country. It also encourages the creation of new programmes and the improvement of existing ones in order to increase access to housing and improve the quality of life of the poor.



Experience

The experience acquired allows for the generation of spaces for exchange to achieve, through the institutions in charge, the encouragement of the financial system on the subsidy programmes implemented and the work methodologies applied together with the Bank and the Government in programmes for access to social housing. Between 2019 and 2021, together with the National Commission for Housing and Human Settlements (CONVIVIENDA, by its acronym in Spanish), the Bank for Housing Production (BANHPROVI, by its acronym in Spanish) and the Property Institute (IP) of Honduras, it was possible to train professionals in the sector and financial intermediaries in that country through the transfer of knowledge and the creation of two key regulations: 1) Intervention in human settlements and 2) Resettlement due to vulnerability.

Offer details

Our offer is based on the dissemination of knowledge and methodologies for technical assistance in the implementation of pilot projects related to the temporary use of public spaces adjacent to restaurants, cultural establishments and related services, as well as active guidance for the development of public open spaces, the implementation of active roads and public spaces in the vicinity of food markets.



Experience

In Peru, a national urban design strategy based on guidelines for the responsible use of public open spaces was proposed through the implementation of pilots. The aim of these actions was to generate a supply of bio-safe spaces, through civic capacity building, to address the health crisis. The proposal institutionalises tactical urban planning practices from the central government through a multi-sectoral work methodology that enables economic reactivation and ensures the physical and mental health of the inhabitants.









Central Public Procurement Office (Perú Compras - Peru Purchases)

The Central Public Procurement Office (Perú Compras - Peru Purchases) facilitates the articulation of public entities with suppliers of goods and services through the mechanisms of Framework Agreements, Corporate Procurement and Reverse Auction, for the timely attention of their needs in an efficient and transparent manner. It promotes economic growth for a better quality of life for the population, guaranteeing a responsible fiscal policy within the framework of macroeconomic stability. It also develops efficient, transparent, agile and innovative procurement mechanisms and strategies for the State in order to contribute to the well-being and competitiveness of the country.

Offer details

Perú Compras (Peru Purchases) the Peruvian government's public procurement centre, operates a total of 41 electronic catalogues in the form of a virtual shop with nationwide coverage. Through this 100% electronic platform, which is permanently available, procurement is facilitated for state entities at the national level, reducing procurement times and generating an efficient use of resources by promoting competition. In this way, a significant contribution is made to the dynamisation of the economy and the development of small and micro enterprises. Our offer is based on the design of strategies and policies for the implementation and operability of functionalities related to state procurement, reaffirming the relevance of incorporating new and greater technological options that simplify the work of the participating entities, accompanied by rules that reduce deadlines and costs in the different phases of public procurement.





Experience

Between 2020 and 2021, activities were developed in the framework of the Memorandum of Understanding between the Directorate of Public Procurement and Contracting (*ChileCompra* of Chile) and the Public Procurement Central (*Peru Compras* of Peru). The beneficiary population included *ChileCompra* managers and officials where, through the exchange of experiences and lessons learned, best practices in public procurement systems and the use of Framework Agreements tools were established. There is currently a continuity of bilateral cooperation actions between the two countries, which have been maintained since the signing of the Memorandum of Understanding, demonstrating its value over time.

National Institute for the Defense of Competition and Protection of Intellectual Property (INDECOPI).

The National Institute for the Defense of Competition and Protection of Intellectual Property (INDECOPI, by its acronym in Spanish) has as its functions the protection of consumer rights and the promotion of a culture of honest market competition, safeguarding all forms of intellectual property. The Organisation for Economic Co-operation and Development (OECD) and the Inter-American Development Bank (IDB) identify it as a regional and global benchmark in the fight against cartels, the promotion of free competition and the articulation of public policies. Peru became the third country in the world chosen by the OECD to establish a Regional Competition Centre, joining South Korea and Hungary. The institution also hosts the World Intellectual Property Organisation (WIPO) Academy.

The Peruvian National Integrated Consumer Protection System protects consumers who are exposed to discriminatory treatment by suppliers on the basis of origin, race, sex, language, religion, opinion, economic status or of any other kind. The National Institute for the Defense of Competition and Protection of Intellectual Property (INDECOPI) has the duty to promote non-discrimination in consumption and to sanction any infringement of this fundamental right. Our offer is based on the design of strategies and policies to implement regulatory compliance, market monitoring and joint work with other state entities to fight discrimination through consumer protection supervisions.

Experience

Since 2020, INDECOPI's Special Monitoring Centre was launched in order to emphasise monitoring activities to streamline the collection, processing and analysis of information captured from various sources, through the use of artificial intelligence tools. In this way, the facts, situations and problems faced by citizens when purchasing a good or contracting a service were studied in depth. In 2020 and 2021, in the framework of South-South Cooperation, training and feedback activities were developed between Peru and Uruguay for capacity building and exchange of best practices in consumer protection, many of which were implemented in those countries.

Experience

Between 2019 and 2021, the Directorate of Distinctive Signs of INDECOPI, carried out various collaborations through seminars with Latin American countries (Colombia, Mexico, Guatemala, Trinidad and Tobago, among others) sharing their experiences on: 1) The generation of intellectual property value in the tourism and gastronomy sectors through the international recognition of traditional cuisine by applying the Guaranteed Traditional Specialities system. 2) Economic development tools for the country through the protection of Designations of Origin and Geographical Indications in relation to brands.

National Archives (AGN)

The National Archives (AGN, by its acronym in Spanish) is an organisation created in 1972 with the mission of proposing and executing policies for the conservation, restoration, registration, dissemination and service of the Nation's documentary heritage. Its work consists of issuing standards on the production, rationalisation and administration of documents in public archives at the national level to facilitate decision-making in the governmental function. It also proposes and supports professional training and specialised training in archives. It began its competencies related to the Culture Sector in 2010, with a wide jurisdictional scope at the regional and sub-regional level.

Our offer is based on the dissemination of knowledge and exchange of experience in the processes of documentation collection, inventory, cataloguing and service for the control of the documentation of an archive with a historical character.



Experience

Between 2018 and 2019, the project "Description, digitisation, conservation and restoration of documents" was developed in favour of Paraguay. Through this project, state officials from the same country benefited, training them in the areas of organisation, description, conservation and digitisation, sharing knowledge and appreciation of our common traditions and history, and promoting good professional practices. On the other hand, in 2020, the project "Rescue of a century" was carried out for the benefit of Uruguay. Through this programme, knowledge was shared on archival description and preventive conservation, providing general guidelines for the implementation of documentary recovery. The training provided strategies for the processes of documentary rescue and loss of information. Several technicians from the *Museo de Colonia de la Intendencia* (Uruguay) were trained and the result was a multiplier effect of the practice in the institution in question.









Ministry of Foreign Trade and Tourism (MINCETUR)

The Ministry of Foreign Trade and Tourism (MINCETUR, by its acronym in Spanish) defines, directs, coordinates, executes, and supervises the country's foreign trade (with the exception of tariff regulation) and tourism policies. The Programa de Desarrollo Alternativo, Integral y Sostenible (DAIS).(Alternative, Integral and Sustainable Development Programme) is aimed at changing the economic matrix towards a licit and sustainable economy, prioritising the reduction of economic dependence on illicit coca cultivation towards the consolidation of licit markets to mitigate damage and promote the sustainable use of natural resources. Our offer is based on the dissemination of knowledge and experiences to replace illicit coca leaf with alternative crops, prioritising the promotion of new crops in areas where coca is eradicated.

Experience

Between 2018 and 2019, the project "Advice on the implementation of the DAIS Programme" was carried out for the National Anti-Drug Secretariat (SENAD, by its acronym in Spanish) of Paraguay. The programme was able to benefit SENAD officials through the contextualisation of the Peruvian model in alternative, integral and sustainable development for the substitution of marijuana crops with the methodologies provided by the National Commission for Development and Life without Drugs (DEVIDA), managing to formulate and develop their own alternative development programmes. Currently, Paraguay's alternative development programmes have annual fiscal budgets and are implemented by the National Anti-Drug Secretariat, as part of the country's anti-drug policy.

Our offer is based on the dissemination of the knowledge acquired during the development of the *Habla Franco* service, which seeks to raise awareness and change attitudes that lead to the adoption of healthy lifestyles to prevent early drug use. The Habla Franco service operates in the modalities of telephone and on-line attention.



Experience

Between 2017 and 2018, workshops on "Technical advice on the implementation of guidance and counselling services specialised in drug issues" were held for Argentina, Chile and Paraguay. Specifically, the National Service for the Prevention and Rehabilitation of Consumption and Alcohol (SENDA) of Chile and the National Anti-Drug Secretariat (SENAD) of Paraguay were the beneficiaries through the training of more than 15 professionals related to the sector. As a result, several Peruvian care methodologies were applied to the national contexts of these countries, and subsequently implemented in their specialised drug counseling and guidance services, where programmes have fiscal budgets that take into account the techniques learned.

Training of facilitators and training in the *Escuela de Campo de Agricultores* (ECA) (Farmer Field School) methodology for Integrated Pest Management (IPM)





Offer Details

Inadequate pest control triggers the indiscriminate use of "kill all" pesticides, generating economic and environmental losses and deteriorating people's health. As a result, productivity is reduced, product quality is lowered and access to more competitive and profitable markets is limited due to the presence of chemical residues above the minimum permitted limits. Our offer is based on the design of Plant Health strategies and policies accompanied by Good Agricultural Practices (GAP) with the objective of training facilitators to develop training curricula and training sessions so that the producers themselves can implement Integrated Pest Management (IPM) through a process of learning and participatory research in the plots, under real socio-economic and agro-ecological conditions.



Experience

In 2021, the project "*Escuela de Campo de Agricultores para el Ministerio de Agricultura de República Dominicana*" ("Farmer Field School for the Ministry of Agriculture of the Dominican Republic") was developed, training strategic personnel from the Dominican Republic, who were provided with knowledge for the development of Participatory Rural Appraisal (PRA) and Integrated Pest Management (IPM).







Ministry of Health (MINSA)

The Ministry of Health (MINSA, by its acronym in Spanish) leads the National Health System based on Integrated Health Networks, the policy for universal health insurance, intersectoral policies and actions on social determinants for the benefit of the health and well-being of the population. Health sector institutions are working together to achieve a strengthened, integrated and efficient health system that provides quality services and accessibility in order to guarantee a health benefits plan through universal insurance and a social protection system.

Offer Details

The Ministry of Health has organised health services into Integrated Health Networks (IHN). The IHN are the set of organisations that provide or make institutional arrangements to provide an equitable and comprehensive portfolio of health services to a defined population through articulation, coordination and complementarity that is accountable for the health and administrative outcomes and health status of the population they serve. In this context, the Ministry of Health (MINSA) has established a Geospatial System of Integrated Health Networks (GEORIS) that allows for the collection, analysis, identification and interoperability of primary and secondary information from various inter-institutional sources at the national level in a modular way. GEORIS is the technological support for decision making of the RIS, based on an assigned territory, which uses information from the health sector and other social sectors to improve health services. Our offer is based on the design of strategies and policies to implement Integrated Health Networks (IHN) in other Countries, through the experience and recognition gained in the development and implementation achieved.



Experience

Since 2019, the implementation of the Geospatial System of Integrated Health Networks (GEORIS) was launched for the benefit of the total population of Peru (33,039,912 inhabitants). This development was recognised by the Sasakawa Prize in 2020, which was awarded by the World Health Organisation (WHO). In addition, by means of a Supreme Decree and a Ministerial Resolution, the National Plan for the Implementation of Integrated Health Networks was approved, making use of this technological tool (GEORIS), registered with INDECOPI, at the national level.

The National Institute for Agricultural Innovation (INIA, by its acronym in Spanish) is the body responsible for designing and implementing the national agricultural innovation strategy through policy formulation in its category. As an entity for development, innovation (R&D&I) and continuous improvement in the agricultural sector, its mission is to increase productivity and improve levels of competitiveness through the development of research activities, technology transfer, conservation and use of genetic resources, as well as the production of seeds, seedlings and reproducers of high genetic value, seeking agricultural sustainability, food security and adaptation to climate change.

Our offer is based on transferring acquired experience, providing basic knowledge and exchanging experiences on the use of molecular biology and bioinformatics techniques for the genetic characterisation of animal, plant and micro-organism species in agriculture, in order to support conservation and improvement programmes.



Experience

In 2021, the project "*Pasantía en cultivo in vitro de tejidos vegetales* - *cacao y piña*" ("Internship in in vitro plant tissue culture – cacao and pineapple") was developed for the University of Antioquia (Colombia). The project provided training on in vitro cultivation techniques for cacao and pineapple, through the exchange of experiences, benefiting Master's students from the University of Antioquia. As a result of the programme, research work was carried out on the efficient and eco-friendly management of cacao.







Ministry of Agricultural Development and Irrigation (MIDAGRI)

The Ministry of Agricultural Development and Irrigation (MIDAGRI, by its acronym in Spanish) is the leading public body in agrarian matters that develops strategies to provide quality public goods and services to thousands of families in the country. It works in concordance with the National Agrarian Policy, defining the medium- and long-term orientations, in favour of the sustainable development of agriculture with the aim of activating development and social inclusion, for the benefit of the rural population. It contributes to Peru's food and nutritional security, promoting the sustainable use of water, forestal and wildlife resources, which promote social and economic development, through a productive conservation approach oriented towards environmentally responsible and sustainable use.

Good shearing practices and primary added value of alpaca fibre





Offer Details

Camelid breeding is an ancestral practice and is one of the most important productive and economic activities in the high Andean zone of Peru. Peru is home to around 65% of the world's vicuña population and 87% of the world's alpaca population, and is the main exporter of fibre from these species. The growing demand from the international market for these fibres has led to the optimisation of production processes (animal care, shearing, fibre handling) and their standards, as well as to the creation of technical standards to reduce waste and ensure the welfare of the animal. Support services for production and marketing have also been developed, such as the work of the master fibre graders. Our offer is based on transferring the experience acquired in the value chain through short courses, where experiences are exchanged on:

- Good shearing practices and alpaca fleece handling.
- Good animal husbandry practices: animal welfare in the alpaca shearing process.
- Categorisation and classification of alpaca fleece.
- Primary value-added processes for handling alpaca fibre.



Experience

In 2019, the project "Fortalecimiento de competencia técnicas y comerciales de especialistas en camélidos sudamericanos domésticos (alpaca y llama)" ("Strengthening the technical and commercial skills of specialists in domestic South American camelids (alpaca and llama))" was developed between Peru and Bolivia, where through the exchange of experiences, several specialists from the Ministry of Rural Development and Land of Bolivia benefited.

Good Agricultural Practices (GAP) for potato cultivation, processing and promotion





Offer Details

Experiments in potato processing have been carried out since 1978 with research carried out by the International Potato Centre in Huancayo and MINAGRI, through the National Programme of the National Institute for Agricultural Innovation (INIA). The range of byproducts developed is wide and diverse, such as Tunta (dehydrated potato), dried potato, Tocosh (fermented potato), yellow potato puree, crisps, white potato flour, peeled and cut potato for poultry, native potato vodka and native potato medicinal alcohol. Our offer is based on the dissemination of knowledge and exchange of experiences, to provide information on Good Agricultural Practices (GAP) on the cultivation of native potatoes and its production chain oriented to the processing of by-products. All the processes involved in their growth and development are covered, from the preproduction, production, harvest and post-harvest stages.



Experience

Since 1984, collaborations have been carried out for the development of increased productivity, added value and promotion of consumption, in favour of countries such as Nicaragua, Bolivia, Belize, benefiting professionals and technicians from the agricultural world.







Ministry of Production (PRODUCE)

The Ministry of Production (PRODUCE, by its acronym in Spanish) aims to formulate, design, implement and supervise national and sectoral policy on fisheries, aquaculture, MSEs and industry. Its mission is to promote the development of the agents of the productive sector, fostering innovation, quality and environmental sustainability, contributing to competitiveness. PRODUCE issues norms and technical guidelines for fisheries and aquaculture management, industrial fisheries, medium and large-scale aquaculture, industrial standardisation, as well as for controlled products, productive innovation and technology transfer. It promotes the development of productive ecosystems in fisheries, aquaculture, industry, micro, small, medium and large enterprises, domestic trade and cooperatives. It revalues artisanal fishing, promotes production for direct human consumption and seeks to improve fishermen's living conditions.

Technical assistance for the implementation and/or strengthening of the Aquaculture Extension Service





Offer Details

Aquaculture extensionism is the set of actions to accompany smallscale producers towards the consolidation of their economic and productive self-sufficiency. In Peru it is incorporated as a public policy through personalised, targeted and planned educational programmes that integrate different knowledge for the formation of capacities in the service of aquaculture producers, seeking their intersection with national and regional sector institutions, research and development centres. Our offer is based on sharing the experience gained during the implementation and strengthening of the Aquaculture Extension Service on the basis of specific components, the main ones being: 1) Productive scaling up, 2) Business management, 3) Formalisation, 4) Commercial articulation, 5) Associativity and 6) Innovation.



Experience

Since 2012, the Ministry of Production has initiated aquaculture extension activities, coordinating actions with the different actors in the production chain. In 2018, an internship was carried out at the Aquaculture Extension Service for the Sub-Secretariat of Fisheries and Aquaculture of the Ministry of Economy, Development and Tourism of Chile, for the benefit of small-scale fish farmers in that same country. The activities initiated by the Chilean Undersecretariat of Fisheries and Aquaculture take as a reference part of the Peruvian model and have been transferred to the Instituto Nacional de *Desarrollo Sustentable de la Pesca Artesanal y de la Acuicultura de Pequeña Escala* (National Institute of Sustainable Development of Artisanal Fisheries and Small-scale Aquaculture) (INDESPA, by its acronym in Spanish) of that same country, which provides training and technical assistance to small-scale fish farmers in its jurisdiction.



Measures to prevent, deter and eliminate illegal, unreported and unregulated (IUU) fishing

Exchange of experiences to prevent, deter and eliminate illegal, unreported and unregulated (IUU) fishing: Monitoring, Enforcement and Satellite Tracking System





Offer Details

The Ministry of Production promotes the sustained development of fishing activities as a source of food, employment and income. The General Directorate of Fisheries and Aquaculture Supervision, Control and Sanctioning supervises and controls fisheries and aquaculture management through the use of technologies to discourage the illegal exercise of extractive activities. To this end, it has tools such as SISESAT, SITRAPESCA, SIGPESCA, among other mechanisms that allow for adequate traceability of hydrobiological resources. Our offer is based on the design of strategies and policies to strengthen measures aimed at preventing, discouraging and eliminating illegal, unreported and unregulated (IUU) fishing; and contemplates supervision and control actions in the fishing production chain in the maritime and continental sphere, through technological tools such as the Satellite Monitoring System (SISESAT, by its acronym in Spanish) for the surveillance of the extractive activities of national and foreign fishing vessels, in order to ensure the responsible use of hydrobiological resources.





Experience

In 2021, the "Exchange of experiences in policies and plans to strengthen measures to eradicate illegal, unreported and unregulated (IUU) fishing by national and foreign flag vessels" was developed for the benefit of Panama. Through this programme, it was possible to benefit Panamanian officials in the sector, strengthening their capacities in terms of supervision and control for the sustainable development of fisheries and aquaculture based on the experience developed in Peru.





Technological Production Institute (ITP)

The Technological Production Institute (ITP, by its acronym in Spanish) was created in 1979 as a scientific and technological research centre with the aim of improving the productivity, quality and profitability of companies through research, development, innovation, adaptation, transformation and environmentally sustainable technology transfer in coordination with productive support entities and the science, technology and innovation ecosystem. Its function is to ensure compliance with technical norms, good practices and quality standards, through the Centres for Productive Innovation and Technology Transfer (CITEs) so that companies can develop better quality products and take advantage of national and international opportunities.

Technology transfer, training and technical assistance for the aquaculture and fisheries <u>production chain</u>





Offer Details

The Ahuashiyacu Aquaculture and Fisheries CITE aims to support technology transfer, training and technical assistance to business units in the aquaculture and fisheries production chain with a focus on cost efficiency and process standardisation (seed production, pre-farming and fattening). Our offer is based on transferring the experience acquired on good practices in aquaculture health, nutrition and transversal technologies; with the aim of increasing the consumption of fish products, covering topics such as: primary processing and preservation of fresh fish, fish smoking, principles of preservation of cured products, salted products, fish freezing, preparation of nuggets and burgers of Amazonian fish, and quality control.



Experience

In 2020, the course "Optimisation of resources in the aquaculture feeding system" was developed for the SENESCYT of Ecuador. The programme included the design of a curriculum with a total of 40 hours, benefiting students and teachers from the Instituto Superior *Tecnológico* El Oro and the Instituto *Superior Tecnológico Luis Arboleda Martínea*, both in Ecuador. Both students and teachers put the knowledge acquired into practice as part of the development of their academic projects.

Innovation and technology transfer in the lumber and furniture sector

Good practices for the management of technological services in the lumber and furniture industry





Offer Details

Our offer is based on sharing the experience acquired in the provision of technology transfer services for the development of the lumber-furniture sector, as well as knowledge in research procedures and methodologies on artificial drying programmes, identification tools for tropical timber species and the development of humidity maps. In addition, input is provided based on standards achieved as part of good practice in technology transfer services, with an emphasis on product design and quality.



Experience

During 2014, 2015 and 2016, projects were developed to exchange experiences in furniture design as a "Diseño País" (Country Design) concept for various entities such as the Institute for Design and Technological Innovation (Mexico), the Centre for Technological Innovation (Bolivia), Inti Madera (Argentina), Uruguay (LATU) and CATAS (Chile), with the aim of achieving a differentiation strategy, as well as the harmonisation of procedures and methodologies for testing finished products. The beneficiaries implemented these and other methodologies as a strategy of cultural differentiation in their products.



Forest timber innovation and technology transfer

Management of technological services for the timber forestry industry





Offer Details

Our offer is based on sharing experiences on the design and provision of technology transfer services for the development of the timber forestry sector, as well as on sharing knowledge on research procedures and methodologies applied to artificial drying programmes for species that are difficult to dry, qualitative segmentation of sites for forest plantations, timber technology, design and development of timber products, among others. In addition, the standards achieved and good practices for the development of timber harvesting activities are considered, such as: censuses, directed logging, operational and economic planning.





Experience

In 2022, the "Alliance for the development of the forest-biomass ecosystem" was developed together with Spain and Mexico. Research projects were generated through the exchange of experiences on the use of forest biomass as an energy generator in the forestry industry. This dynamic benefited professionals and entrepreneurs who shared their strategies in specific forestry clusters, transferring their learning to various enterprises in their countries.





National Science and Technology Innovation Council (CONCYTEC)

The National Science and Technology Innovation Council (CONCYTEC, by its acronym in Spanish) is the governing body of the National System of Science and Technology and Technological Innovation (SINACYT, by its acronym in Spanish), responsible for directing, promoting, coordinating, supervising and evaluating the actions of the State throughout the country, concerning science, technology and innovation. CONCYTEC's mission is to guide the actions of the private sector in its field of action, as well as to execute support actions that promote scientific and technological development in the country.

Foresight is a social science discipline that studies the future in order to understand and influence it. A country that does not use Foresight is condemned to live in a future created by others, where it will undoubtedly not be a protagonist, but a mere spectator. Our offer is based on the design of strategies and policies to identify the best future scenarios, making the best use of a country's resources through the development of long-term plans.



Experience

Since 2004, Peru has been developing "Basic training workshops for specialists in technology foresight ", supporting various organisations in countries such as SENACYT in Guatemala, CONICYT in Nicaragua, Observatorio del Caribe Colombiano in Colombia, Instituto Bioatlántica in Brazil, Ministry of Science, Energy and Technology in Jamaica; as well as projects for the exchange of experiences on the use of forest biomass (as a generator of bioenergy) for the forestry industry with Spain. Through these programmes, more than 100 technology foresight professionals have benefited, not only from science, technology and innovation entities, but also from national planning bodies. The countries and/or entities that have received assistance are implementing their own foresight units based on some of these trainings learned.

Experience of the Crime Observatory in analysing the phenomenon of femicidal violence





Offer Details

The Crime Observatory Office of the Public Prosecutor's Office has extensive experience in processing data and statistics on violence against women at the national level through its Femicide Registry. Our offer is based on the design of strategies and policies for the collection of information on various cases of femicide and background violence of the victims, for the identification of the dependents of the victims, compliance with protection measures, the status of the legal situation of the accused, and the deployment of crosscutting actions to promote speed and efficiency in prosecutorial investigations.



Experience

During 2018 and 2019, exchanges of experiences were held between representatives of the Public Prosecutor's Office of Peru and institutions of the justice sector in El Salvador to strengthen the Salvadoran Institute for the Development of Women (ISDEMU). Based on this technical support, institutional capacities were strengthened for the creation of a single registry of victims of femicidal violence through the design of methodologies for the criminological analysis and follow-up of cases of violent deaths of women, the design of public policies for public security, and criminal prosecution in the area of violence against women. The positive evaluations led to the decision to continue with a second phase with the participation of Peru, El Salvador and Spain.
